




This chart shows the total general purpose revenue Cottonwood Creek Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Cottonwood Creek Charter School is \$3,042,492, of which \$2,551,793 is Local Control Funding Formula (LCFF), \$230,800 is other state funds, \$215,200 is local funds, and \$44,699 is federal funds. Of the \$2,551,793 in LCFF Funds, \$166,315 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Of that amount, \$379,096 is tied to actions/services in the LCAP and \$2,305,899 is not included in the LCAP. 
# Increased or Improved Services for High Needs Students in the LCAP for the 2022-23 School Year

In 2022-23, Cottonwood Creek Charter School is projecting it will receive \$166,315 based on the enrollment of foster youth, English learner, and low-income students. ### **Plan Summary [2022-23]**

#### **General Information**

Cottonwood Creek Charter School is an independent charter school within the Cottonwood Union School District. Cottonwood Creek is a Kindergarten through eighth grade non-classroom based charter school that offers site based classes (4 days a week) as well as a traditional homeschool program. Cottonwood Creek Charter School will be in its 12th year of operation during the 2021/22 school year.

The Cottonwood Creek Charter School is located in downtown Cottonwood, a rural, northern California town with a population of just over 3,000 inhabitants. Cottonwood Creek Charter serves students living in Cottonwood, Anderson, Redding, Red Bluff and throughout the Shasta and Tehama counties. Cottonwood Creek has established a strong record of high academic standards as well as award-winning enrichment and technology programs.

Cottonwood Creek Charter School is open to all students who go through the application and lottery process. The students, parents, and staff form a community of individuals identified primarily by their common goals of high academic standards, maintaining highly qualified teachers, and promoting quality enrichment and elective classes. It is the belief of the school that small class sizes and an overall small school size allow students greater opportunities to achieve their academic and enrichment goals within a supportive community.

#### **Reflections: Successes**

Cottonwood Creek Charter School continues to be one of the highest performing public schools in Shasta County. The latest data from the California School Dashboard is from 2019. The data from the 2019 Dashboard indicated that Cottonwood Creek was performing in the green (highest) level for English Language Arts. This performance was 42.8 points above standard and reflected a gain of 17.4 points from the previous year. For math, The data from the 2019 Dashboard indicated that Cottonwood Creek was also performing in the green (highest) level. This performance was 29 points above standard and reflected a gain of 18.3 points from the previous year. Also, the CAASPP Scores from 2021 showed Cottonwood Creek Charter with a Proficiency Rate of 73% for ELA and a Proficiency Rate of 63% for Math.

#### **Reflections: Identified Need**

Cottonwood Creek's Math scores on the CAASPP continue to be a focus area. Cottonwood Creek Staff have identified gaps in the K-5 Math Curriculum (Number sense, math facts, traditional algorithms). K-5 teachers will be heavily supplementing their math program with research-based math supplemental programs.

The entire school staff has identified writing as need across all grades levels. Staff meetings have already taken place to identify and study school wide writing programs.

K-3 parents continue to request more electives and enrichment opportunities in the after school/elective program.

Cottonwood Creek parents are excited about the school's new construction project of a multi-purpose room. When completed, the new gym will greatly benefit our after-school elective program. As gathered from school climate surveys, parents continue to see school campus and safety enhancements as a need.

#### **LCAP Highlights**

After meeting with our stakeholders and reviewing a survey of needs also completed by our stakeholders, the 2022/23 LCAP was modified according to their concerns.

During the 2020/21 school year, Cottonwood Creek Charter School's CAASPP Proficiency Rates were 73% Proficient in ELA and 63% Proficient in Math. K-8 Teachers and administration have noticed that Cottonwood Creek's Math Scores have increased over the past few

years due to the school's emphasis of Number Sense in the primary grades. School staff will continue to established the priority of addressing math gaps in our K-5 curriculum. Supplemental math materials will be purchased and implemented at the K-5 level in order to address this area of need.

Cottonwood Creek continues to administer a school climate survey to parents. This school climate survey (Survey Monkey) gathers parental input on school strengths and weakness. School staff, administration, and the LCAP Parent Advisory Committee utilizes the results of the school climate survey to address LCAP priorities.

Some key areas that are addressed in this year's LCAP include:

- Construction of new Multipurpose Room
- School safety concerns / campus maintenance and upkeep concerns / school facility upgrades
- Continue to increase after-school/elective/enrichment opportunities for students
- Increase music class / instruction opportunities for students
- Address Math Program gaps in K-5 Math Curriculum (supplemental instruction needed).

Students in the K-3 classes receive a strong foundation in both reading and math and a strong Learning Center has been created to support struggling students in reading and/or mathematics. Classroom teachers and the Learning Center use research-based programs (Read Naturally / SIPPS) to support struggling readers. Reading daily for 30 to 45 minutes is emphasized in our Reading Renaissance Program. Cottonwood Creek Charter School continues to support the library with many additional fiction and non-fiction books each year. Providing technology instruction/keyboarding to students in 2nd-8th grades is also an important part of our school program. Cottonwood Creek Charter School continues to perform at a high academic level in English/Language Arts.

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
